To assist us in receiving donations, facilitating fundraising programs and events, collecting and sharing stories, administering research, grants and charitable activities, and otherwise carrying out our functions, Cause2Cure Ltd (“Cause2Cure”, “we”, “us”) collects personal information about you.

Personal information may include your name, contact details, donation information, and information you voluntarily provide, including stories, images, audio, video, and, where relevant, sensitive information such as health information.

If you choose not to provide personal information, we may not be able to respond to your enquiry, process a donation, share your story, or provide certain services or opportunities.

### How we use and disclose personal information

We may use and disclose personal information to:

- process donations and issue receipts
- communicate with donors, supporters, volunteers, and participants
- deliver fundraising activities, events, and programs
- collect and share stories to raise awareness of Motor Neuron Disease (MND)
- meet legal, regulatory, and reporting obligations
- administer research, grants, and charitable initiatives

We may disclose personal information to trusted third-party service providers who assist us in operating our activities, such as payment processors (including Square), communications platforms, IT providers, and event services. These providers receive only the information necessary to perform their services.

Some service providers may be located overseas, meaning personal information may be disclosed outside Australia. We take reasonable steps to ensure overseas disclosures are handled in accordance with Australian privacy requirements.

## **Direct marketing**

Depending on how you interact with Cause2Cure (for example, if you donate, volunteer, attend an event, or subscribe to communications), we may use your personal information to send you updates about our work, fundraising activities, and opportunities to support our cause.

You may opt out of receiving communications at any time using the unsubscribe option or by contacting us.

## **Donation (Square – Donation Pages)**

Cause2Cure collects personal information to process donations via Square, issue receipts, and communicate with you (if you choose).

Payment details are handled securely by Square. Cause to Cure does not store full credit card details.

---

## **Sensitive information, stories & children**

Cause2Cure may collect sensitive information, including health information, where it is relevant to our charitable purpose and only with informed consent.

Stories, photographs, audio, and video recordings are collected and used only in accordance with the consent provided. Where children are involved, consent is obtained from a parent or legal guardian. Consent may be withdrawn at any time, subject to practical limitations.
